Ecocert is the environmental certification organization approved by the State in France, accredited by COFRAC under standard EN 45011. It is a guarantor of independence, impartiality and the requisite skillsets. **Ecocert** is the

- leader and pioneer in France of the certification of organic agriculture, with more than 70% market share
- developer of frameworks for the certification of products and services relating to social and environmental issues

TechnicoFlor is recognized as a supplier of raw materials (perfumes).

The **Cosmebio** Charter was developed in 2002 and now has some 140 members covering some 4,000 certified products. The Charter is a document representing the interests or concerns of all those involved in the natural and organic cosmetics field (suppliers of raw materials, laboratories, bespoke manufacturers and distributors).

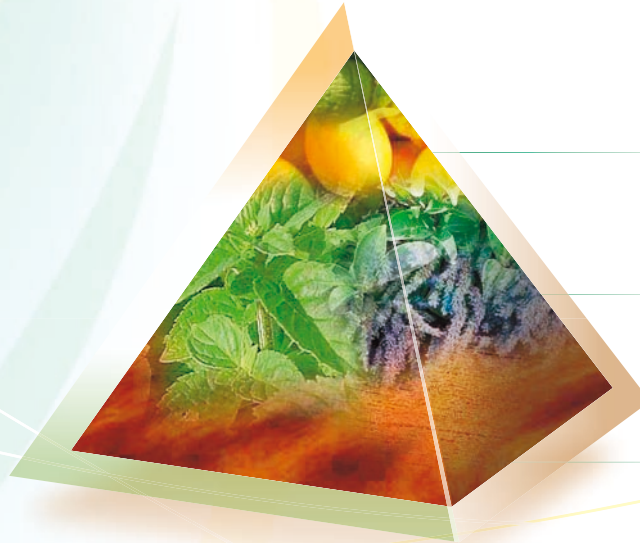

To be **Eco-Label** compliant means using compounds developed from processes which reject the substances most hazardous to health and the environment, and which stringently limit the recourse to allergenic or similar compounds.

Eco-Label fragrances provide an olfactory input into **cosmetic applications**, into **body care products, perfumes, and soaps**, including **detergent** and **household cleaning products**.

Eco-Label is a European environmentally-friendly label. It testifies to products meeting criteria of biodegradability and toxicity thresholds with respect to human health and the environment, without adverse effect on their performance compared to similar products for the same purposes.

Not only must biodegradability criteria be met, but **Eco-Label** products completely ban the following compounds:

- polycyclical and nitrated musks
- products classified CMR 1, 2 or 3
- substances classified as very toxic and/or toxic for the environment and which can lead to long term harm to the aquatic environment
